Call for nomination of suitable persons to be appointed as members of the Advisory Board of the Municipal Infrastructure Support Agent

The Minister of Cooperative Governance and Traditional Affairs (CoGTA), Dr Nkosazana Dlamini Zuma hereby calls for nomination of suitable persons for consideration as members of the Advisory Board for the Municipal Infrastructure Support Agent (MISA) for a period of three years. MISA is a government component established in 2012 under the CoGTA Portfolio with the mandate to render technical advice and support to municipalities towards the optimisation of municipal infrastructure provision. The agency was created through Presidential Proclamation 29 of 2012, published in accordance with section 7A of the Public Service Act, 1994, Proclamation 103 of 1994 (the "PSA"). The role, powers and functions of MISA are further articulated in the Governance Notice on the Administration and Operations of MISA (the "Operational Notice") issued by the Minister in May 2013.

Procedures for appointing members of the Advisory Board for MISA are set out under section 7A (4) of the PSA and Part Five of the Operational Notice. The functions of the advisory board are to advise the Minister and the Head of MISA on strategy, the District Development Model (DDM) and spatial planning, as well as measures to support and strengthen the capacity of municipalities to manage their own affairs, exercise their powers and perform their functions necessary for the development, maintenance and operations of municipal infrastructure.

Nominees must have adequate relevant experience and/or expertise in any of these areas: **public infrastructure, water and sanitation, human settlement, waste management and environment, transport, land and agriculture, regional development and planning, energy, infrastructure procurement, development economics, trade and investment, arts, culture and heritage, public administration, infrastructure finance and investment, and ocean economy.**

Candidates for the board membership are required to be fit and proper and to be appropriately qualified with the requisite level of knowledge and expertise in any of the fields listed above. As such, the appointment procedure to be followed will entail vetting of the shortlisted candidates, verification of their qualifications and criminal records. Persons who are un-rehabilitated insolvent, mentally ill persons (as declared by a court of law) members of Parliament, provincial legislature or municipal council, those removed from an office of trust on account of breach of fiduciary duties, those convicted of an offence in South Africa or elsewhere, other than an offence committed before 27 April 1994 associated with a political objective and sentenced to imprisonment without the option of a fine or in the case of fraud or any other offence involving dishonesty, to a fine or imprisonment or both or is otherwise disqualified in terms of the Companies Act, 71 of 2008 are ineligible for nomination and appointment as members of the advisory board.

Candidates may be nominated by any member of the public or organisation and each nominee must give consent to their nomination in the prescribed consent form. Nominations for the advisory board should be made on the prescribed form obtainable along with other reference documents such as the operational notice on MISA website (www.misa.gov.za) or requested by email on nominations@misa.gov.za.

All duly completed nomination forms and enquiries should be submitted to the Director: Legal Services, Mr Lufefe Sigcau by electronic mail at the above-mentioned address.

Submission of nominations for members of the Advisory Board for MISA closes at **16h00** on **18 October 2021**. No late Nominations will be accepted.
