#### TENDER REFERENCE NUMBER: MISA/PP/ESD/006/2022/23

- The Municipal Infrastructure Support Agent issued a request for proposals, on e-tenders portal, for the Appointment of a Service Provider to conduct project preparation for Eastern Seaboard Development as and when required for a period of three years on 08 August 2022.
- 2. On 23 August 2022, a non-compulsory briefing session was held virtually on Teams meeting.
- 3. During the briefing session, the following discrepancies were noted:
  - 3.1. On page 7 of the Tender Document, under the Tender Data, clause 3.7. There is a statement that reads as follows: "No Tender will be considered unless the Tenderer attends the compulsory briefing session and site visit".

Kindly note that the briefing session was not compulsory; bid proposals submitted by tenderers that did not attend the briefing session will also be considered.

3.2. On page 16 of the Tender Document, under the Tender Data, clause 5.11.7. Evaluation Schedule 3, the Evaluation Criteria for Approach Paper; and page 49 of the Tender Document, under Evaluation Schedule 3, the Evaluation for Approach Paper, the evaluation criteria for Skills Transfer has been amended as follows:

3.3. On page 17 of the Tender Document, under the Tender Data, clause 5.13. number 4 reads as follows: "Tender offers will only be accepted if: the tenderer is registered with the Construction Industry Development Board in an appropriate contractor grading designation.".

Kindly note that tenderers do not have to be registered with the Construction Industry Development Board to bid for this tender.
