TENDER NOTICE

APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE FINANCIAL MANAGEMENT AND SUPPLY CHAIN MANAGEMENT RISK MANAGEMENT AND COMPLIANCE SUPPORT TO THE MUNICIPAL INFRASTRUCTURE SUPPORT AGENT (MISA)

- 1. Reference is made to the bid that was published on the 15 November 2023 on E-Tenders with closing date of 6 December 2023 and compulsory briefing session that was held on 22 November 2023.
- 2. During the compulsory briefing session, the following was noted:
- 2.1. Under Functionality Evaluation criteria (**Company experience**, and **References**) there was a misallocation of points where the maximum possible points were 15 points instead of 10 points.
- 2.2. Under the Scope of Work, the bidders are required to provide two (2) resources for Consultant Acquisition Management, but at Functionality Evaluations criteria only one (1) resource was stated.
- 2.3. On the advertised tender document, Under Table 1: Specific goals for the bid and points claimed, Preference Point System was not complete.
- 3. To remedy the above-mentioned discrepancies, the Functionality Evaluation criteria and Preference Point System has been revised as per Table 1 and Table 2 below:
