**ADDENDUM NOTICE No.2**

**APPOINTMENT OF A SERVICE PROVIDER TO PROVIDE CLEANING SERVICES FOR THE MUNICIPAL INFRASTRUCTURE SUPPORT AGENT(MISA) FOR A PERIOD OF 36 MONTHS. REF: MISA/CS/002/2024/25**

- Reference is made to the bid that was published on the 30 September 2024 on E-Tenders and MISA website with closing date of 22 October 2024 and non-compulsory briefing session that was held on 08 October 2024.
- During a non-compulsory briefing session, a question was raised why MISA is excluding bidders with private sector experience, because cleaning is cleaning and project specifications are similar.
- MISA confirms that references from private sector will be accepted as evidence of company experience under the functionality criterion.
- To remedy the above-mentioned discrepancies, **second stage: technical functionality** under **Evaluation criteria**; clause 9.3.1 company experience has been revised as per Table below:
