ADDENDUM NOTICE NO.1

- 2. During the compulsory briefing session, the following discrepancies were noted:
 - 2.1. Page 7 of the Tender Document, under Submission Data, clause number 4.9, closing date not indicated.
 - 2.2. Page 31 of the Tender Document, under Functionality Criteria, Schedule B Expertise of Key Personnel. There are inconsistencies of total points on clause 1 (Contract Manager) and clause 2 (Site Agent) with the Functionality Evaluation Criteria on page 31 and 32.
- 3. To remedy the above-mentioned inconsistencies, the Tender Document has been updated as follows:
